




The Noosa Map is  $345 \text{mm} \times 485 \text{mm}$  in size and mainly distributed via the Noosa Visitor Information Centre at Hastings Street as well as via many Tourism Noosa members.

The map advertising opportunities are in an advertorial template style with content to be provided following booking confirmation. Tourism Noosa will layout the ads and supply proofs for approval.

As the Noosa Map is distributed to visitors already in the destination, advertising is available exclusively to all members providing tourism-related services e.g. cafés, restaurants, attractions, retail, tours and events. Advertising spots are not available to accommodation providers.

60,000 copies of the map will be distributed, providing a detailed town map with street listings, a regional map, and number references for advertisers.

The maps will be printed in a tear-off pad format, with a new design that has a straight-forward folding method.

As part of Tourism Noosa's sustainability charter, The Noosa Map is produced using recognised environmental printing standards.
